- Do not start your title with "The...".
- Do not use quotations around the title.
- IMPORTANT! Please make sure your title does not have any trade and/or commercial product names.

Learning Objectives:

- Provide at least one measurable and concrete objective and start each sentence with one of these objective verbs (Define, List, Describe, Discuss, Explain, Identify, Demonstrate, Differentiate, Compare, Design, Formulate, Evaluate, Assess, Name, Analyze).
- Do not use the terms learn or understand they are not measurable.
- Learning objectives must be written from the learner's perspective. What will the learner be able to do after hearing your presentation? Define what? Describe what? List what?
- Do not start your learning objective with the number, bullet, asterisk, or any other special characters! See instructions for writing learning objectives.
- NOTE: Abstracts submitted without one of the above objective verbs risk either not being considered for presentation OR jeopardizing the future session's eligibility for continuing education credit approval. Please, do not include your ABSTRACT TEXT in this area.
- Learning Objectives will not be included in the abstract text word count.
