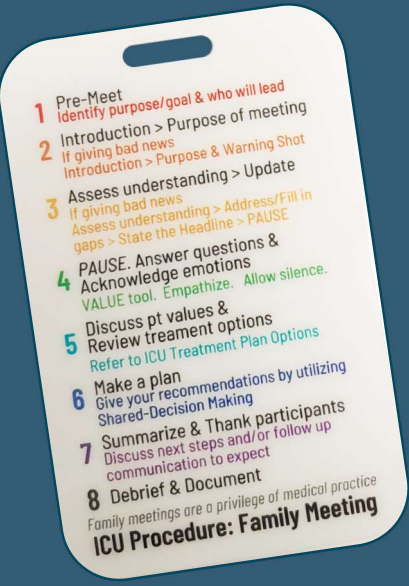
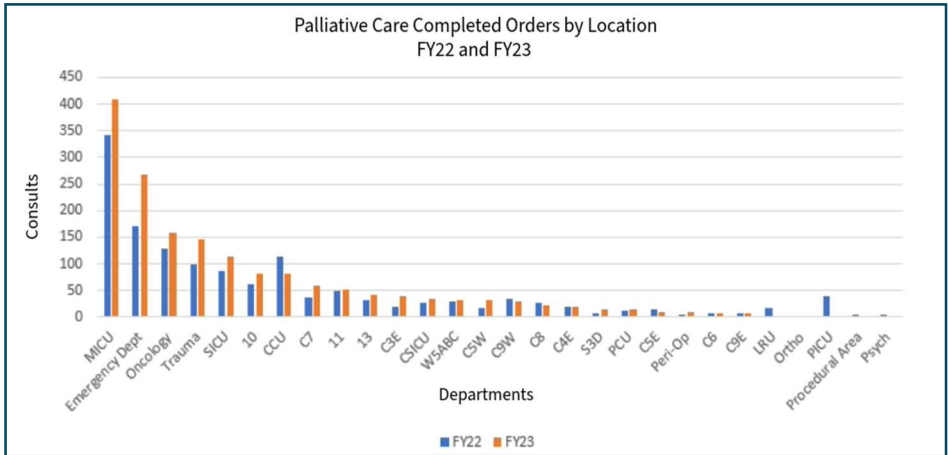

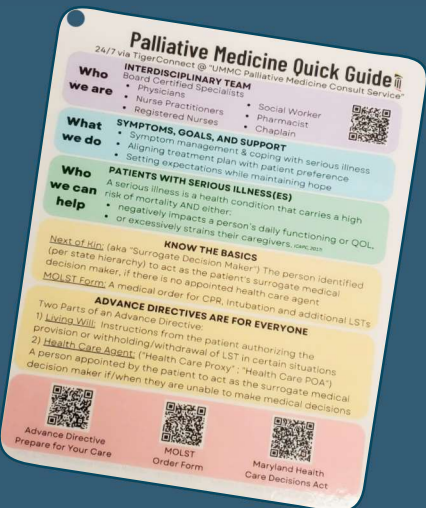

Meetings focus on prompted writing exercises and group reflection sessions. Providers engage in attentive listening, craft personal responses, and share their narratives in a safe environment. An interdisciplinary team collaborates closely with a patient's existing medical and surgical teams, crafting a tailored plan that centers on the patient's needs. This approach not only enhances the patient's quality of life, but also positively impacts their family.

Dr. Lutz presented at the 2023 GSA on “The Hidden Toll of Incarceration: Exploring the Link Between Incarceration Histories and Pain Among Older Adults in the United States.” Using HRSA data, he explored the association between incarceration histories and the reporting of moderate-to-severe pain and pain with physical limitations. This association was found to be strong and remained after adjusting for various factors. This study spotlights the need to address pain in individuals with incarceration histories, particularly among vulnerable groups.
