ABOUT MACS FOR MOMS

MACS for MOMs (Maternal Opioid Misuse Model) provides support to maternal health providers in addressing the needs of their pregnant and postpartum patients with substance use disorders (SUD), particularly opioid use disorder (OUD). MACS for MOMs, an expansion of the Maryland Addiction Consultation Service (MACS), is a statewide program that is free to all providers.

Maryland is part of a cohort of awardees funded to implement the Maternal Opioid Misuse (MOM) model. The model is a multi-pronged approach that focuses on improving care for pregnant and postpartum Medicaid beneficiaries diagnosed with OUD.

Funding for MACS for MOMs is provided by Maryland Department of Health and the Centers for Medicare and Medicaid Services.

MACS for MOMs provides support for all maternal health providers, including OB/GYNs, certified nurse midwives and physician assistants.

CONSULTATION

When you call the MACS for MOMs line, you can expect:

- ✓ Our behavioral health consultant to intake your question or request, and arrange for a formal consultation from one of our MACS' consultants at a time that is convenient for you.
- ✓ While all services are free of charge, regardless of your patient's insurance status, we are required to ask for patient's insurance type.
- ✓ No PHI will be collected but to facilitate the call process be prepared to share the history of the presenting problem and your main consultation question.
- ✓ MACS for MOMs will send you a written summary of the call for your records.

TRAINING

MACS for MOMs connects maternal health providers with free training opportunities for continuing education credit and ongoing support.

- ✓ DATA 2000 waiver qualifying training for maternal health providers to prescribe buprenorphine for OUD.
- ✓ Virtual and in-person training events to stay up to date and increase comfort in caring for pregnant and postpartum persons with SUD, particularly OUD.
- ✓ Expand treatment knowledge through case-based learning with providers and experts in MACS for MOMs TeleECHO™ Clinic.
