

The Department of Radiation Oncology's Preclinical Radiobiology Laboratory, led by Thomas MacVittie, PhD, professor, and Ann Farese, MT (ASCP), MS, MA, research associate, received a five-year \$51,017,445 contract from Aeolus Pharmaceuticals,

Inc. and the Biomedical Advanced Research and Development Authority (BARDA) of the U.S. Department of Health and Human Services to further develop and test one of their lead compounds (AEOL-10150) for the treatment of potentially fatal radiation-induced lung injury. The principal investigator of the study, Michael Garofalo, MD, assistant professor, Department of Radiation Oncology, will lead the


development and testing of the drug, to include a pivotal trial designed to lead to FDA licensure. AEOL-10150 is a novel small-molecule catalytic antioxidant compound that reduces oxidative stress, inflammation and subsequent tissue damage signaling cascades consequent to radiation exposure. If FDA approved, the drug would be given as a part of treatment in the event of a radiation-based accident or attack and would be a candidate for testing in the phase I program of the Cancer Center toward reducing potential normal lung damage in

cancer patients receiving radiation therapy to the thorax. There are currently no FDA-approved drugs with such an indication. The Preclinical Radiobiol-

## In the News





**Elizabeth (Lisa) Kimbrough, PhD, MPH,** assistant professor, Center for Integrative Medicine, died of brain cancer on January

3, 2011. Nationally and internationally, Dr. Kimbrough earned a reputation as a leader in research of mind/body medicine.

From 1991 until her untimely death at the age of 53, she authored and coauthored more than 75 publications and in 2008–2009 she served on the review panel of five peer-reviewed journals. Prior to her death, her research projects included studying the effectiveness of Mindfulness-

based Stress Reduction (MBSR) and meditation to help childhood abuse survivors, persons suffering from depression, and severe rheumatoid arthritis. She worked closely with Brian Berman, MD, professor Department of Family & Community Medicine, and director, Center for Integrative Medicine, to develop a collaborative relationship with the Chinese University of Hong Kong.

In recognition of her research, Dr. Kimbrough received many awards, including the Francisco J. Varela Memorial Grant Award from the Mind and Life Institute and the George Family Foundation New Researcher Award.

From the late 1980's until the early 2000's she studied epidemiological issues in Nepal. She assisted with studies conducted by the United States Agency for International Development and Johns Hopkins University such as the prevention of malnutrition, the impact of maternal supplementation on early infant mortality rates and the impact of Vitamin A supplementation on childhood mortality and morbidity in Nepal.

Dr. Berman said, "Lisa influenced everyone in the Center for Integrative Medicine as an example of a dedicated researcher who knew how to balance her professional career with her personal life as a wife and mother. Her circle of friends spanned the globe. A testament to her life was the hundreds of messages she received from colleagues and friends on her Caring Bridge website. In addition, our staff volunteered 24-hour support with her homecare until she went to Nepal where she passed away."

A memorial service for Dr. Kimbrough was held in February in Charleston, West Virginia.
